LLCs are: Limited Liability Companies.

In partnerships you are responsible for what you both do.

You can separate your finances and taxes.

LLCs are great for smaller, lower revenue businesses.

It's less expensive than a corporation.

Corporations are great for anything that's going to grow bigger.

LLCs pay: gross revenue franchise tax.

A corporation doesn't have extra gross revenue franchise tax.

Corporation = the shareholders are the owners.

Corporations are great if you have people who want to invest in your business.

Corporations are great for a family business.

You can convert from an LLC to a corporation.

When you form a corporation, by default it is a \"C-Corp\".
